### ROCKY POINT FIRE/EMS BOARD NEWS

Four Board members, Fire Chief, and 2 guests attended the December meeting. Minutes and money matters were handled, which included a reported \$730 contribution from Quilt for a new computer for the department.

Chief's report summarized all the activity from our busy volunteers. They responded to 5 MVAs without transport and 1 medical without transport, making a total of 72 calls for the year. Two drill sessions added another 38 hours, with the year's training totaling 545 hours. Aspen Room was used by Quilt and 1 business meeting of the Board and Volunteers this month.

Greg Sullivan reported for the volunteer association, beginning with thanks to Gale Lemas and Dee Sullivan for all their hard work and help with the Fire/EMS dinner on Dec. 4<sup>th</sup>. The generator still needs permits. Total cost for the unit is over \$17,000, with about \$13,500 funded by a grant and the remaining \$4,000 donated by the VFA.

Old business recapped the ever-present audit. Mike Black has submitted all the requested paperwork and is writing a letter asking for acceptance. The Board will make a decision on the purchase of 2<sup>nd</sup> ambulance when Chad finds a suitable

vehicle. Chad is also investigating refurbishing 2191 and purchasing another ambulance in the \$15,000 price range. The VFA has pledged \$10,000 toward purchase, and the Board may be able to add \$5,000.

The single new business item was the possibility of developing a supplemental budget, if a 2<sup>nd</sup> ambulance is purchased prior to the January Board meeting.

With business complete, the meeting adjourned. Come to any of the meetings on the 2<sup>nd</sup> Tuesday of each month. *Complete & official minutes available at Fire Hall, 356-2205. This Institution is an equal opportunity provider.*

## YOU ASKED

***How come Rocky Point residents are billed if they use ambulance transportation to the hospital?***

Rocky Point has only a fire district, for which property owners pay taxes. So if you have a fire at your home, district volunteers will respond, and that response is covered in what you pay for fire protection. Because of our equipment and well-trained volunteers, our fire district enjoys an ISO

rating of 8-B, meaning you benefit with a reduced homeowners' insurance rate.

But your tax dollars don't cover all the fire department's expenses. To meet budget, the annual BBQ, donations, grants, and ambulance income make the department solvent. And none of that income covers ambulance runs or EMS response. That portion of service must be self-supporting through fees for service.

To help residents cover ambulance and EMS expenses not paid by insurance, our fire department offers ambulance insurance. For \$150 every 2 years, all members of a household are covered. Another \$35 per year provides helicopter ambulance service for severe situations, again for everyone in your household.

Rocky Point's fire department is staffed entirely by volunteers. We're fortunate to have so many selfless individuals, willing to cross-train in fire and EMS services and be available for all our emergencies.
